MEMORANDUM

Subject: Promotion through Limited Departmental Examination from the post of TGT to PGT for the year 2014-15 to 2018-19 from Main Panel.

In continuation to this office memorandum dated 05.02.2019 and 06.02.2020 the following TGTs who had been promoted to the post of PGT in their respective subject with year of eligibility as mentioned against their name in column 9.
