MEMORANDUM

SUBJECT: Filling up the Posts of Stenographer Grade-I by promotion for the year 2020 (Main Panel).

The Competent Authority has approved promotion of the following Stenographer Grade II to the post of Stenographer Grade I in the Pay Scale of Level 6 as per 7th CPC and posted to KVS HQ/ROs as shown in column 6 against their name. They must communicate their unconditional acceptance positively by 15.09.2021 and get relieved for joining the place of posting as Stenographer Grade I after availing of joining time as per rules. If they fail to get relieved by 22.09.2021 this offer of promotion will automatically be treated as withdrawn. No communication will be made/entertained in this regard and further they would be debarred from getting further promotion for 01 year with attendant consequence such as seniority etc. with effect from 22.09.2021 as per KVS (HQ) letter No.6-6/1999/KVS (HQ)RPS dated 04.09.2008.

- 2. The promotion made under SC/ST quota is subject to production of recent certificate obtained from the competent authority of State Govt. in support of his continuing to belong to SC/ST as the case may be.
- 3. The employee will have the option to get his pay fixed from the date of promotion or from the date of increment in the lower post. The option should be exercised within a month from the date of joining on promotion.
- 4. No extension of joining time shall be allowed except for reasons of illness/confinement of the employee duly supported by medical certificate from Chief Medical Officer / Medical Supdt. / Civil Surgeon of Govt. Hospital / Distt. Hospitals or from Chief Medical Officer of the Hospital of Public Sector Undertakings/Projects to which the school is attached/Military or Command Hospital as a case may be. The request, if any, for extension should be submitted through proper channel by 22.09.2021 to KVS (HQ) positively.

5. It is also made clear that representation for either change of place of posting on promotion or for extension of time to join the post (other than covered under para4) above will not be entertained under any circumstances.
