## SUBMISSION OF ANNUAL ACCOUNTS FOR THE YEAR 2013-14 FOR CERTIFICATION BY CAG.

As per the letter No.AMG-IV/SAR/Misc./9-2/2014-15 dated 19-5-2013 issued by the Director General of Audit (Central Expenditure), New Delhi (Annexure - ), the Accounts must be approved by the GB/Executive Commission/Competent Authority, as may be prescribed in the bylaws/ Memorandum of Association/Act/Rules & Regulation before submission to CAG for its certification.

The consolidated Annual Accounts of the Sangathan for the year 2013-14 in the prescribed format with schedules thereon have been compiled and placed before the Finance Committee KVS, for its recommendation to the Board of Governors of KVS for conveying approval for handing over the Accounts to CAG for its audit.

Joint Commissioner (Finance), KVS informed that Sangathan prepared the Annual Accounts of 2013-14 in the new format and require some more time to give final touch before its submission to CAG for audit. the Considering above submission and keeping in mind the complexity of the new the Committee format permitted KVS to complete the Annual Accounts before 30<sup>th</sup> June 2014 and directed the KVS place to the annual accounts for the year 2013-14 before the Finance Committee for its approval.

REVISION OF HONORARIUM TO COURSE DIRECTOR, ASSOCIATE COURSE DIRECTOR AND RESOURCE PERSON FOR 21/22 DAYS INSERVICE COURSES FOR PROFESSIONAL GROWTH OF THE EMPLOYEES.

The Committee recommended the proposed rates of Honorarium to the Board of Governors, KVS for its approval.

KVS organizes In-service Training programmes every year. During In-service Training programmes, Experts (both, from within and without KVS) are engaged as Course Director, Associate Course Director, and Resource Person for Two spells (1st spell of 12 days and IInd of 10 days) which, when combined, marks the training complete. Besides, there are also training programmes of 21 days of single spell for TGT (Art Edu.) TGT (WET), TGT (Librarian), PRT(Music) category of teachers for their professional growth.

Board of Governors (BOG) in its 96<sup>th</sup> meeting held on 28-31-2014 had revised the honorarium to Experts who are invited as Guest Speaker for conduct of training sessions. Recoing in view the fact that more than three years have elapsed and rates have been revised in various areas to keep pact with inflation, the need for revision of honorarium rates for RVS Experts who are engaged as Course Director, Associate Course Director & Resource Persons is also being felt. # Renewal of Portfolio Management Contract for another three years with State Bank of India.

The Board of Governors of Kendriya Vidyalaya Sangathan in 11:90<sup>th</sup>meeting heid on 30.8,2011 approved the appointment of State Bank of India as Portfolio Fund Manager for investment of turplus amount of Employees Provident Fund of Kendriya Vidtalaya Sangathan for one year on experimental basis and extendable upto two more years subject to their performance.

Accordingly Kendriya Vidyalaya Sangathan appointed State Bai k of India as Portfolio Fund Manager (PFM) w.e.f. 16. 2.2011 for a period of one year and in view of their sat factory performance, the period has been extended upto 15. 2.2014.

team consisting of Sri. Rajesh Yadav, Deputy Commissioner (Finance) and Sri. Govind Kumar, Finance Officer was deputed to SBI from 8.5.2014 to 10.5.2014 to inspect the books of Account of SBI and to submit their report. As per their report dated 23.5.2014 (Annex. IV), the annualized yield earled by the KVS is 9.44% (from 16.12.2011 to 31.3.2014 (unjudited)) which is more than the present PF rate of interest. # TC CONSIDER AND APPROVE THE PROPOSAL FOR RE-EMPLOYMENT OF SUPERANNUATING TEACHERS & PRINCIPALS UP TO 62 YEARS OF ACE

Of late, it has been observed that in KVS a number of sanctioned teaching & non-teaching posts are lying vacant. As on 01.05.2014 the number of sanctioned post are 56937 out of which 9854 teaching posts are vacant due to various resigns like superannuation/ resignation/ death/ delay in resolution process/ non joining of selected candidate on the ct recruitment at their posted place/ litigations etc.

KVS is in process for filling up of 577 posts of TGTs 1139 po ts of PRTs for the year 2011-12 and 4043 posts of PGTs/ TG // PRT/ Misc. Teacher etc. for the year 2012-13 and 2013-14 and the process will be completed by September, 2014. He vever, there are possibilities that some posts may remain that after the said exercise also. As of now Kendriya Valayas are appointing contractual teachers as a stopgap are angement for performing required activities against the valant posts. It is felt that the quality of contractual teachers are not upto the mark.

The Chairman VMC/ PTA Members / Parents/ VIPs are recuesting again and again KVS to fill up these vacancies by recular employees in the interest of the students of Kendriya vici valayas.

After detailed discussion the committee deferred the proposal.
