OFFICE ORDER

In the audit report issued by the O/o DGACR on the accounts for the year 2013-14, an observation regarding the non-settlement of outstanding paras was pointed out for compliance. The issue was discussed by the BOG KVS and as per the decision taken by the Board of Governors, KVS, all Dy. Commissioners of the Regional Offices are expected to conduct Audit Adalat once in a quarter to review the Internal Audit/AG Audit Paras so as to minimize the number by means of settlement. Officers of KVS HQ/RO used to take part in such Audit Adalat being conducted by the Regions in the year 2012-13 and 2013-14.

- 2) In spite of the best efforts taken by various RO's, the number of Internal Audit Paras liable for settlement as on 31.03.2015 has been arrived at as 5409 in 25 RO's and it has to be brought down to the minimum level. DGACR Dept may soon conduct transaction as well as SAR Audit on the accounts of KVS HQ in **May 15 to July 15** and before the commencement of such audit the number should be reduced to the barest minimum.
- 3) It is, therefore, directed all the Deputy Commissioners of the Region to conduct the Audit Adalat in May 15/June 15. Since 15 RO's do not have the Finance Officers/Section Officers it is proposed to depute Officers from KVS HQ/Other RO's to the Regions where the number of audit paras are more than 100 as per the details given below:-
