## OFFICE-ORDER

In continuation of Kendriya Vidyalaya Sangathan (KVS) office-order of even number dated 04.03.2014, the approval of Hon'ble HRM-cum-Chairperson KVS is hereby conveyed for establishment of a new **Kendriya Vidyalaya at BSF Academy, Tekanpur, Distt. Gwalior, (Madhya Pradesh)**, in lieu of the sanction of Kendriya Vidyalaya CISF, NISA, Hakimpet, Secunderabad (Telangana State), under Civil Sector during the academic year 2014-15 as CISF has requested KVS to drop the proposal of opening of a new Kendriya Vidyalaya at CISF, NISA, Hakimpet, Secunderabad (Telangana State), vide letter No. F C-11014/NISA/EO/KV2014/1067 dated 02.04.2014.

Further, pursuant to Clause-I(ii) of Annexure-I of the norms prescribed for opening of new Kendriya Vidyalayas under Civil Sector, the sponsoring authority i.e. DIG, BSF Academy, Tekanpur (M.P.) is required to transfer the identified and demarcated land to KVS on lease or permanent transfer prior to opening of new Kendriya Vidyalaya and making it functional.

Necessary administrative orders for opening the said new KV with class I to V will be issued immediately after transfer of land in favour of Kendriya Vidyalaya and thereafter Kendriya Vidyalaya will be made functional in the temporary accommodation provided by the sponsoring authority viz BSF Academy, Tekanpur.

In case, the required extent of land as per KVS norms is not transferred in favour of Kendriya Vidyalaya within one year of the issue of this communication, this approval will be withdrawn and will be utilized for another suitable location.
