OFFICE-ORDER

The Kendriya Vidyalaya Surda, Ghatsila, District East Singhbhum (Jharkhand) which was closed w.e.f. 01.04.2014 on account of unsafe building provided by Hindustan Copper Limited (HCL) is hereby re-opened to make functional in the alternative building temporarily i.e. Marwari Hindi Uchch Vidyalaya, Ghatsila proposed by Deputy Commissioner, East Singhbhum District with immediate effect with the following conditions:-

- Kendriya Vidyalaya Surda will function at this alternative location, till the earlier school building is fully repaired by the State Government/HCL as committed vide Memo No. 994/GEM dated 04.04.2014 of Deputy Commissioner, District East Singhbhum.
- 2. The Deputy Commissioner, District East Singhbhum (Jharkhand) will arrange the following room/facilities in the alternative building immediately:-
- a) 03 rooms to be created for housing office and to keep all other items pertaining to various departments and items of common minimum programme.
- b) Provision for portable water.
- c) Construction of additional urinals for Boys & Girls temporarily (10+10).
- d) Provision for safe approach road to the building.
- e) Provision for electricity supply, fixtures and fittings
- The Vidyalaya will function from class III to X and XII during the academic year 2014-15.
