ORDER

In supersession to previous orders, the approval of the Commissioner, Kendriya Vidhyalaya Sangathan is hereby conveyed to re-constitute the "Internal Complaints Committee" at Kendriya Vidyalaya Sangathan (HQ) to deal with the complaints regarding sexual harassment of women at workplace, in terms of the provisions of Section 4(2) of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 enforced on 9th December, 2013. Accordigly, the following members are nominated for constituting the 'Internal Complaints Committee' at KVS(HQ) level to deal with the complaints of sexual harassment in respect of women employees at KVS(Hqrs.) and the complaints against all Group 'A' Officers of KVS(HQ), Regional Offices, ZIETs and Kendriya Vidyalayas.

- I. Co-ordinate with the NGO member, other members and respective Deputy Commissioner/ Vidyalaya to fix date and time for conduct of enquiry.
- II. Co-ordinate with the NGO member and plan & facilitate the tour program.
- III. The inquiry will be conducted in terms of guidelines contained in the judgment dated 13.08.1997 of the Hon'ble Supreme Court in Vishaka and Others Versus State of Rajasthan & Others and order dated 26.04.2004 passed by the Hon'ble Supreme Court in the case of Medha Kotwal Lele & Others Vs Union of India & others.
- IV. It is mandatory to have one NGO member while investigating the cases of sexual harassment of women employees.
- V. Submission of Inquiry Report with specific findings and supporting documents alongwith her comments/recommendation within a period of one month from the date of such receipt of a complaint.
