Kendriya Vidyalaya Sangathan (KVS) is an Autonomous Body funded by the Ministry of Human Resource Development, Government of India. It's Headquarter is situated at 18, Institutional Area, Shaheed Jeet Singh Marg, New Delhi-110016. Sealed tenders are invited by KVS from the interested firms for procurement of Public Addressing (P.A.) System and its installation in the office premises of KVS (HQ). The estimated cost of procurement is Rs. 10.00 Lakhs.

The Tender -Document may download from website (www.kvsangathan.nic.in) of KVS from the date of its publishing. The Tender Document must be completed in all respect as per items enlisted Annexure-"A" of the document and deposited with the Supply & Services Section, Room No. 213, Kendriya Vidyalaya Sangathan, 18, Institutional Area, Snaheed Jeet Singh Marg, New Delhi 110016 latest by 26.11.2019 up to 1.00 P.M. along with requisite tender fee of Rs.500/-[Rs. Five Hundred Only] & EMD[Bid Security] of Rs.50,000/-[Rupees Fifty Thousand Only] through the DD/Pay Order/Bankers' Cheque only drawn in favour of "Kendriya Vidyalaya Sangathan, New Delhi". The bid envelope should be super-scribed in capital letters as "TENDER FOR P.A. SYSTEM AND IT'S INSTALLATION".

The tenders received till 01:00 P.M. on 26.11.2019 shall be opened on 26.11.2019 itself at 3.30 P.M. by the designated Committee. The representatives of the firms are allowed to witness the process of opining of the Bids. The tender received after the stipulated date and time shall not be considered and liable to be rejected summarily.

TERMS & CONDITIONS

- 1. The Tenderers shall fill in all the required details in Tender Form and rates may be quoted in Annexure "A" at Column No.6 & 7 respectively.
- 2. The tenderers shall be deemed to have studied the items, specifications and details of the supplies to be made within the time schedule. The bidders/their representatives are permitted to be present at the time of the opening of the tenders.
- 3. The tenderer shall quote rates for specific items, taxes, and cartages etc. as applicable, whatsoever. The rates have to be FOR to KVS HQ. The competent authority reserves the right to decide any of the disputed terms of the tender in the interest of the organisation, if felt necessary.
- 4. There should not be any overwriting or corrections in the tenders. If the figure is required to be amended, it should be neatly scored out, the revised figure written above and the same attested with signature and date otherwise their tender will be liable for rejection.
- 5. In the event of acceptance of the quotation and placing of the order for purchase, the articles ordered may be subjected to an inspection by any representative of KVS [HQ] and are liable to be rejected if the articles supplied are not according to the specifications given in tender document.
- 6. If the supplier fails to supply any quantity of materials within the time stipulated in the supply order, the undersigned will be at liberty to cancel the order and procure the materials from other sources and the EMD amount shall stand forfeited.
- 7. It would not be binding upon the authority to accept the lowest tender. The authority reserves the right to accept the tender in whole or in part, as may be decided. Any dispute shall be subject to the jurisdiction of appropriate Hon'ble Courts of Delhi.
- 8. Tax will be deducted at source as per Goods& Services Tax Act and Income Tax Act as per Prevailing rates.
- 9. Provision will have to be made for maintenance of these equipment's and the firms may furnish their rates for AMC.

- 10. The work relating to the installation of the equipment would be completed in a week's time.
- 11. The firm can visit the conference room (if conference room is available) on a mutually convenient working day between 10 A.M to 5.30 P.M. Until the last date of filling the bid.
- 12. Rates quoted in the BOQ should be inclusive of all related wooden works, civil works and installation charge.

13. Tender Fee/EMD/Bid Security:

- (a) The firms are required to deposit a Tender fee of Rs. 500/[Rupees Five Hundred Only] & EMD/Bid Security of Rs.50,000/[Rupees Fifty Thousand Only]. It will be deposited by the tenderer
 through bank DD/Pay Order (cheque not acceptable) drawn in
 favour of the "Kendriya Vidyalaya Sangathan (HQ), New Delhi".
 The tenders without enclosing Bid Security will be rejected
 summarily. The quotations without Bid Security will not be accepted
 in accordance with Article 182.1 of the Accounts code of KVS.
- (b) The Bid Security of those firms whose tenders are not approved will be refunded. However, no interest will be payable by Kendriya Vidyalaya Sangathan.
- (c) The Successful bidder will be required to furnish a Performance Security of Rs. 1, 00,000/-[Rupees One Lakhs Only] through Bank Draft/Pay Order [Cheque not acceptable] before taking over the assignment. It should remain valid for a period of Sixty Days beyond the date of completion of all contractual obligations of the supplier including warranty obligations.
- (d) The Bid Security will be refunded to the successful bidder on receipt of Performance Security.
- (e) Kendriya Vidyalaya Sangathan reserves all the rights for placing the order to any reliable supplier at the L1 rates quoted by any other bidder, if deemed fit, in the interest of the organization.

(f) The payment will only be released after completion of work after due certification of the installation of complete PA system by the Works Branch, KVS.
