Madam/Sir,

You are aware that Kendriya Vidyalaya Sangathan is establishing Digital Language labs in 276 KVs, and the equipment for modernization of existing Science labs has been installed in 653 KVs. There is a need to train teachers to optimize the use of these facilities. 
The Course Directors should coordinate with the following to fix the schedule of training at the nearest Vidyalaya equipped with above facilities.
